#### GENERAL REQUIREMENTS

A candidate seeking admission to the Master's Degree Programme of Covenant University must be a graduate of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division). Candidates are also to note that there are other requirements that may be specific to a College and/or a Programme. The Postgraduate Programmes available in the two Colleges of the University and their respective additional entry requirements are as follows:

#### 1. FULL TIME PROGRAMMES

##### I. COLLEGE OF DEVELOPMENT STUDIES

###### A. SCHOOL OF BUSINESS

###### 1. DEPARTMENT OF ACCOUNTING

M.Sc Accounting (18 months)

#### Eligibility:

- a) A Bachelor's Degree in Accounting of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).
- b) A sound Bachelor's Degree in related disciplines such as Finance, Financial Economics, Computer Science, Management Information System, of Covenant University or any other University approved by the Senate of Covenant University. Such candidates may, however, be required to make up for any deficiencies at the lower level.
- c) Possession of relevant final professional certificates such as ICAN, ACCA, CPA may be considered as an enhancement of admission chances. In any case, no applicant without a first Degree will be considered for admission.

#### 2. DEPARTMENT OF BANKING & FINANCE

M.Sc Banking & Finance (18 months)

#### Eligibility

Candidates must possess a Bachelor's Degree in Banking & Finance, Accounting, Economics or Business Administration of Covenant University, or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

#### 3. DEPARTMENT OF BUSINESS STUDIES

M.Sc Business Administration (18 months)

**Eligibility:** (a) A minimum of Second Class (Lower Division) Degree in Business Studies of Covenant University or any other University recognized by the Senate of Covenant University.

(b) A candidate may be required to take additional courses in areas where he/she is found to be deficient.

#### B. SCHOOL OF HUMAN RESOURCE DEVELOPMENT

##### 1. DEPARTMENT OF LANGUAGES

M.A. English Language (18 months)

**Eligibility:** Candidates must possess one of the following qualifications:

- a.) A Bachelor's Degree in English of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).
- b.) A Bachelor's Degree in Linguistics (with courses in English Language/Literature-in-English).

#### 2. DEPARTMENT OF MASS COMMUNICATION

M.Sc Mass Communication (18 months)

**Eligibility:** Candidates are expected to have a good Bachelor's Degree in Mass Communication/Communication Studies of Covenant University or any other University approved by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

#### 3. DEPARTMENT OF PSYCHOLOGY

M.A. Counselling (18 months)

**Eligibility:** Candidates must possess a Bachelor's Degree in Counselling from a University recognized by the Senate of Covenant University, Candidates with a minimum of Second Class (Lower Division) with a First Degree in Psychology, Sociology, and other related disciplines can also apply. Such candidates will, however, be required to take specified undergraduate courses.

In addition to general counselling courses, successful candidates could specialize in any of the following:

- i) Forensic Counselling
- ii) Career Counselling
- iii) Marriage and Family Counselling
- iv) Substance Abuse Counselling
- v) Rehabilitation Counselling

There will be supervised practice for 3 months in any of the following settings-hospitals/rehabilitation centres/social work/schools. This is mandatory for all students.

#### 4. DEPARTMENT OF SOCIOLOGY

M.Sc Sociology (18 months)

**Eligibility:** Candidates must hold a B.Sc Degree in Sociology, or related Degrees, of Covenant University or any other University recognized by the Senate of Covenant University, such as Anthropology, Demography, Social Work, or a combination of these and/or other related disciplines in the Humanities, Administrative and Social Sciences, with a minimum of Second Class (Lower Division).

### C. SCHOOL OF SOCIAL SCIENCES

#### 1. DEPARTMENT OF ECONOMICS & DEVELOPMENT STUDIES

M.Sc Economics (18 months)

**Eligibility:** Candidates must possess either

- a) A Bachelor's Degree in Economics of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division), or
- b) A Bachelor's Degree in a related discipline of Covenant University or any other University approved by the Senate of Covenant University, with a minimum of Second Class (Lower Division). Candidates in this category will, however, be admitted on the condition that they will take required courses in which they are found to be deficient.

Ph.D Economics (3 years)

**Eligibility:** Candidates must possess one of the following qualifications:

- i) A Master of Science (M.Sc) Degree in Economics of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of 60% or a Cumulative Grade Point Average (CGPA) of 3.50.
- ii) Any candidate with a CGPA less than 3.50 but with a minimum of 3.00 shall be admitted to the M.Phil/Ph.D Programme in the first instance, with the opportunity to convert to the Ph.D Programme later.
- iii) An M.Phil Degree in Economics of any University recognized by the Senate of Covenant University, with a minimum CGPA of 3.50.

#### 2. DEPARTMENT OF POLITICAL SCIENCE & INTERNATIONAL RELATIONS

M.Sc International Relations (18 months)

**Eligibility:** Candidates must hold a Bachelor's Degree in International Relations or in a related discipline of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

Ph.D International Relations (3 years)

**Eligibility:** Candidates must possess one of the following qualifications:

- i) A Master of Science (M.Sc) Degree in International Relations of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum Cumulative Grade Point Average (CGPA) of 3.50.
- ii) To be admitted direct to the Ph.D Programmes, a candidate must have 60% or a Cumulative Grade Point Average (CGPA) of not less than 3.50.
- iii) Any candidate with a CGPA less than 3.50 but with a minimum of 3.00 shall be admitted to the M.Phil/Ph.D Programme in the first instance, with the opportunity to convert to the Ph.D Programme later.
- iv) An M.Phil Degree in International Relations, or in a related discipline of any University recognized by the Senate of Covenant University, with a minimum CGPA of 3.50.

### II. COLLEGE OF SCIENCE & TECHNOLOGY

#### A. SCHOOL OF NATURAL & APPLIED SCIENCES

##### 1. DEPARTMENT OF BIOLOGICAL SCIENCES

M.Sc Biochemistry (18 months)

**Eligibility:** A Bachelor's Degree in Biochemistry from Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

M.Sc Microbiology (18 months)

**Eligibility:** Candidates must have a Bachelor's Degree in Microbiology or in related fields of Science and Technology from Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

##### 2. DEPARTMENT OF CHEMISTRY

M.Sc Chemistry (18 months)

**Eligibility:** Candidates must possess a Bachelor's Degree in Industrial Chemistry or Pure Chemistry of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

Ph.D Chemistry (3 years)

**Eligibility:** Candidates must possess one of the following qualifications:

- i) A Master of Science (M.Sc) Degree in Industrial Chemistry or Pure Chemistry of Covenant University or any other University recognized by the Senate of Covenant University,

with a minimum of 60% or a Cumulative Grade Point Average (CGPA) of 3.50.

- ii) Any candidate with a CGPA less than 3.50 but with a minimum of 3.00 shall be admitted to the M.Phil/Ph.D Programme in the first instance, with the opportunity to convert to the Ph.D Programme later.
- iii) An M.Phil Degree in Industrial Chemistry or Pure Chemistry of any University recognized by Covenant University with a minimum CGPA of 3.50.

##### 3. DEPARTMENT OF COMPUTER & INFORMATION SCIENCES

M.Sc Computer Science (18 months)

**Eligibility:** Candidates must have a Bachelor's Degree in Computer Science of Covenant University or any other University approved by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

##### 4. DEPARTMENT OF PHYSICS

M.Sc Physics (18 months)

**Eligibility:** a) Candidates must have a Bachelor's Degree in Industrial Physics or Pure Physics of Covenant University or any other University approved by the Senate of Covenant University, with a minimum of Second Class (Lower Division).

- b) Candidates who hold a Bachelor's Degree in Mathematics, Meteorology, Geophysics, Energy, Chemistry, and Physics (with Electronics) of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division), may be considered for admission.

### B. SCHOOL OF ENGINEERING & TECHNOLOGY

#### 1. DEPARTMENT OF CHEMICAL ENGINEERING

M.Eng Chemical Engineering (18 months)

**Eligibility:**

- a) Candidates must have a B.Eng or B.Sc (Chemical Engineering) Degree of Covenant University or any other University recognized by the Senate of Covenant University, with a minimum of Second Class (Lower Division).
- b) Candidates with a Bachelor's Degree in other Engineering disciplines or Physical Sciences, such as Mathematics, Chemistry, Physics and Biochemistry may be considered for admission. Such candidates will, however, be required to register for and pass some prescribed Engineering courses.

Ph.D Chemical Engineering (3 years)

- At least five years post qualification experience.
- Satisfactory performance in the Covenant University Management Test (CUMAT).
- Satisfactory evaluation of the candidate's intellectual capacity, professionalism, maturity, past professional experience and motivation for work.
- Written approval from candidate's place of work/employers allowing him/her to undertake the Programme.
